Dear Reginald Jackson Jr.,

I requested all information regarding my case 243208056-1 on 3rd December 2024. After an extremely long delay of several months, on 28th May 2025 you told me that you would supply the information and I approved the fee on 29th May 2025. It is now the 26th July 2025 and I have not received any information from you regarding my case. I would like to remind you that it is an illegal activity for a police department to withhold the case file from a falsely accused person. I have the legal right to perform a full review of the information that you have in your possession regarding the case to put my not-guilty defense together.

Can you clarify why I have not received the information from the corrupt and toxic Atlanta Police Department after 8 months of waiting for it?

I am still working through the information on my side and I have identified the following activities that your toxic police officers engaged in with me at the Atlanta Airport while I was peacefully waiting at my airline gate for my flight home after my family vacation in Buford, Georgia, USA:

- Physical assault by an Atlanta Police officer three times. Grabbing me, physically wounding me to the point I was bleeding and an extremely dangerous excessive heat assault that had the potential to kill me.
- Theft of my property twice by an Atlanta Police officer.
- An Atlanta Police officer putting \$500 cash into my pocket.
- An Atlanta Police supervisor engaging in the illegal activity of entrapment.
- Atlanta Police supervisor facilitating Atlanta Police officers that had been reported to him as having assaulted me and stolen my property enabling them to engage in further assaults of me that drew blood, had the potential to kill me from an excessive heat assault and another theft of my carry on bag.
- An Atlanta Police supervisor failing to protect me from known dangerous and illegal activity police officers.
- Failing to render basic first aid to a person suffering from the effects of an Atlanta Police excessive heat assault.
- Failing to render first aid to my bleeding wounds that the Atlanta Police officers inflicted on me.
- Atlanta Police failing to call for an ambulance that I requested to treat my medical crisis.
- Atlanta Police failing to take me to hospital for treatment for my medical excessive heat exposure crisis that the officers inflicted on me.
- Failing to give me drinking water when I requested it to treat a medical excessive heat crisis.
- Failing to eventually supply sufficient drinking water to treat a medical excessive heat exposure crisis.
- My requests for medical treatment for my medical crisis were all ignored and I was taken to the Atlanta Jail where I could not access hospital treatment the entire time I was there during 3 days.
- The Atlanta Police stole my carry on bag from me and secretly sent it to the Atlanta Police property department as "Stolen" property. They clearly knew it was my carry on bag and it was clearly labeled on the outside and inside as my property. My understanding was these Atlanta Police officers could legally purchase the bag after 90 days at the Atlanta Police property auction, knowing exactly what it contained and how much to bid for it. The bag contained my computer hard drive with all of my police corruption research on it.

- The Atlanta Police officers that transported me twice in police cars refused my requests for the seatbelt to be worn. They were driving up to 50 MPH at times. The second police car crashed! I did have a lot of strange aches and pains in the jail after that crash that I could not get treated. I do understand that a car crash at 50 MPH without a seatbelt would likely result in serious bodily injuries and may even be fatal. Were these police officers trying to injure and kill me in a car crash like the nuclear whistleblower Karen Silkwood? I am an astronomy, electrical, electronic, solar energy, green energy, and government industry whistleblower and have interacted with the police, FBI, OSHA and international media many times regarding it.
- I have a medical disorder called protein intolerance. It needs daily treatment. During three days in the Atlanta Jail, I could not access any form of treatment for it. Lack of treatment makes me really sick and brings on a wide range of adverse health conditions. Combined with the heat assault, this had the potential to kill me! I regarded this as another form of assault the Atlanta Police Department engaged in with me.
- I spent two nights in the Atlanta Jail sleeping in a cell that was made for two people that actually had four people in it. To get the extra two people into the jail cell, they put foam mats into the sewage that was all over the floor of the prison cell from the leaking toilet. I regarded this as a biological assault on my health by the Atlanta Police Department.
- The second night I was transferred into a different prison cell that had a broken toilet in it that would not flush. It was filled with a weeks worth of fermenting fecal matter and urine that was filling the jail cell with strong smelling biologically toxic Ammonia gas. I regarded this as an assault on my health by the Atlanta Police Department.
- My understanding is the Clayton County Jail in Georgia is one of the most dangerous jails in the USA and there is a high risk of being injured, murdered or dying an "unusual" death at this poorly maintained, overcrowded, sewage toxic, and toxic breathing air facility. I regarded the Atlanta Police Department framing of me to send me there as a way of engaging in further assaults that could have led to further injuries and/or my death, as discussed above.

I do need all of the police videos to put my defense together, as they clearly show all of the above illegal police activity happened. None of the above illegal activity appeared in the police report of the incident. It was all blatantly omitted! Your police report is grossly inaccurate! Why is a fake police report on your computer system regarding this incident?

I am particularly interested in the Atlanta Airport Police station videos that show the theft of my carry-on bag by the Atlanta Police Department and my "Paradoxical Undressing" while I was having a untreated excessive heat exposure crisis in the Atlanta Police Department detention room. I did come to the conclusion that I had a comparable medical crisis to the one Alaska Airlines pilot Joseph Emerson had in the detention room of Portland International Airport, Oregon, USA. It is also my understanding that Joseph Emerson needed medical treatment at a well equipped large city center hospital for his naked medical crisis and the Portland Airport Police may have also illegally withheld medical treatment from him during a potentiality life threatening medical crisis. They are very lucky he did not die in their care!

Because the Atlanta Police Officers withheld all forms of medical treatment from me for excessive heat exposure, this forced me into having to remove all of my clothes to attempt to self-treat the overheating body. I am sure you can appreciate the embarrassment that having to attempt self-treatment of a

medical excessive heat exposure crisis by engaging in naked "Paradoxical Undressing" in the Atlanta Airport police detention room has caused me, knowing it was recorded by several Atlanta Police body cameras and the detention cell cameras.

Given that it is clear to me that the Atlanta Police Department is engaging in a blatant cover up of this toxic incident, I am now giving Atlanta Police Department full authorization to release all information you have on file about me to the general public and the media. This includes all Atlanta Police body cameras and the detention cell camera that shows me naked "Paradoxical Undressing" in the Atlanta Airport police detention cell. Please do not do any redactions. The public and media have the right to see me fully naked, trying to self-treat excessive heat exposure because your toxic Atlanta Police Officers were denying me all forms of basic first aid and medical treatment for it. I understand it is an illegal activity for USA police officers to refuse basic first aid and necessary emergency medical treatment to a suspect.

I did file a police complaint to both police complaints departments that you have in Atlanta. I never heard anything back from either of them regarding if they upheld my complaints. From my perspective, it appears both internal affairs departments engaged in a blatant cover-up of this highly illegal incident.

To wrap up, I have given you full permission to release all information completely unredacted to anyone that requests it, including the media. That includes the approximate hour I was naked inside the Atlanta Airport police detention cell trying to self-treat an excessive heat exposure. Please release everything you have to anyone that requests it. I appreciate your cooperation with this.

As far as I am aware, this would include,

- 911 calls.
- Phone calls.
- Phone texts.
- Police texts.
- Police officer personal and company phone texts.
- All forms of Frontier Airlines communications, including company and personal phone texts.
- All forms of Alaska Airlines communications, including company and personal phone texts.
- Written information
- All radio communication.
- All video recordings
- The names and badge numbers of all police officers involved, of which there were several.
- All body camera recordings.
- All Police station recordings.
- All Police car recordings, I was transported in 2 police cars that had video recordings systems.

In the mean time, I will now be filing two more police complaints about the illegal withholding of the police file from me which I am entitled to review for my upcoming court case. Based on my previous experience with the toxic Atlanta Police Department, I expect my police complaints will be ignored.

Regarding the medical crisis I was in, through research I resolved it into High Altitude Cerebral Edema (HACE) with Paradoxical Undressing (HACEPU). I do believe many airline passengers are displaying this medical condition and it is being misdiagnosed as a mental illness crisis and mistreated by both the airlines and the airport police. It is a medical crisis that needs oxygen administration and electrolyte fluid replacement during the flight and the person needs to go to hospital for diagnosis and treatment once the airplane has landed. The Paradoxical Undressing appears to be a life threatening hot skin Anaphylaxis reaction that may need treatment with an Epinephrine autoinjector.
